

Business Meeting Resolutions

AFWA's voting membership passed four resolutions during it's September 14th Business Meeting:

PROMOTION OF RECRUITMENT, RETENTION AND REACTIVATION (R3) ACTIVITIES WITHIN STATE FISH & WILDLIFE AGENCIES recognizes the importance of R3 efforts through both the CAHSS and RBFF, as the efforts of these organizations are critical to the future of the sports of hunting, angling, boating and shooting.

AN ENDORSEMENT OF FUNDING FOR U.S. FOREST SERVICE RESEARCH AND DEVELOPMENT PROGRAMS THAT PROVIDE MANAGEMENT-RELATED SCIENCE TO STATE FISH & WILDLIFE AGENCIES encourages Congress to fund those research activities of U.S. Forest Service Research and Development program that directly benefit the state fish and wildlife agencies, particularly in the areas of sagebrush ecosystem conservation, fisheries management, wildlife disease management, pollinator conservation, urban wildlife conservation, and the development and implementation of the State Wildlife Action Plans.

2016 Annual Award Recipients

Dan Forster received AFWA's top honor, the Seth Gordon Award for lifetime achievement in conserving North America's natural resources in the public trust and contributing to the programs of the Association.

The **Missouri Stream Team Program** received AFWA's Ernest Thompson Seton Award for leadership in promoting scientific wildlife management and is a great example of how Missourians value conservation of fish, forests, and wildlife, and how the Conservation Department, DNR, and Conservation Federation of Missouri work with citizens to conserve our natural resources.

Project WILD

AFWA staff and leaders have been working behind the scenes with Project Wild leadership for the last six months on the possibility of AFWA taking over management of the K-12 Environmental Education Program that is in 46 states (38 of them through state fish & wildlife agencies). Members approved a motion authorizing staff to continue the process, developing the legal framework for the acquisition and focusing on maintaining sound business practices.

Blue Ribbon Panel Update

Legislation introduced by Congressman Don Young (R-AK) and Congresswoman Debbie Dingell (D-MI) continues to attract bipartisan cosponsors and support. We now have fourteen co-sponsors signed on to the Recovering America's Wildlife Act (H.R. 5650). Directors are encouraged to reach out to those House Representatives that you have personal relationships with and ask for their support of the Recovering America's Wildlife Act of 2016 (H.R.5650).

State Contributions to Canadian NAWCA/NAWMP

Contributions from 37 states to Canadian waterfowl habitat projects during 2015-16 were \$3.063 million US dollars. This is a slight dip from last year's record due to administrative challenges in Illinois where the duck stamp funds could not be appropriated. However, Illinois remains committed to supporting conservation in the Canadian breeding grounds. The slight decline this year is overshadowed by increased investments by a number of other states.

Ducks Unlimited will match \$US 2.863 million of the states' investments and the NAWCA will provide \$US 5.574 million to bring the US investment to \$11.5 million. At the present-day currency exchange rate, the state, DU and NAWCA funds will generate an additional \$US 3.7 million. In combination, the US sourced funds, along with Canadian funds, will generate a total investment in waterfowl habitat in Canada of approximately \$15 million US dollars. This investment in Canadian waterfowl breeding habitat is initiated by the state commitment of \$US 3.063 million, and is a critical component of the success of the North American Waterfowl Management Plan.

Legislative Updates

Water Resources Development Act (S. 2848 and H.R. 5303)

The House and the Senate will be conferencing reauthorizations of the Water Resources Development Act (WRDA) that collectively provide nearly \$5 billion dollars in Army Corps of Engineers (ACOE) water related projects, include numerous provisions for aquatic resource management, direct the ACOE to consider natural and resilient infrastructure when moving forward with certain projects, require that programmatic mitigation plans consider hydroconnectivity, and require that ACOE share water resource data for all ACOE projects on a publicly accessible database.

House-Senate Continue Negotiating Energy-Sportsmen's Bills

House and Senate staffs continue negotiating provisions for a conference agreement on their respective energy and sportsmen's bills. Committee leadership for the conference in both chambers have committed to crafting a final agreement the President will sign and will continue negotiation until the end of this Congressional session.

2018 Farm Bill: AFWA Preparations Begin

AFWA's 2018 Farm Bill Working Group, comprised of regional associations' representation and Agriculture Conservation Committee and working group leadership, will craft a new reauthorization policy platform this fall and winter. The first draft will be available for full committee and State Directors' to review in February 2017. The final reauthorization policy platform will be slated for adoption during the 2017 North American Conference on Wildlife and Natural Resources in Spokane, WA, scheduled for March 4-11, 2017.
