### **Job Summary**

This position will analyze, strategically plan, design and administer statewide hunting, fishing and related outdoor recreation volunteer mentoring programs and outreach events for the Division of Fish and Wildlife; including analyzing internal and external program resources, developing and administering a statewide volunteer management system, designing and conducting volunteer trainings, facilitating communication and coordination between existing mentoring organizations, the DNR and private sector hunting and fishing organizations.

This position will be required to travel to attend meetings which may require staying overnight as well as work varied hours including some weekends, evenings, and long shifts.

#### Minimum Qualifications:

Bachelor's degree in Education, Marketing, Social Sciences, Natural Resources, Environmental Studies, Biological or Environmental Sciences, or related field.

Three years of professional experience in in planning, implementing, and measuring the success of non-formal educational or volunteer management programs, products and services for a regional, statewide, or national-level organization or agency.

\*Master's degree in Education, Marketing, Social Sciences, Natural Resources, Environmental Studies, Biological or Environmental Sciences, or related field may substitute for one year of professional experience.

Knowledge and experience participating and teaching or mentoring the outdoor recreational activities of hunting or fishing.

Experience presenting data and information in an understandable manner to a wide variety of audiences.

Human relations and collaborative skills to effectively work to bring together diverse interests to accomplish common objectives.

Working knowledge of program administration, budget oversight, written reports, partnership coordination, and equipment/supply inventory.

Demonstrated success in effectively managing projects cooperatively with others, setting and meeting deadlines.

Ability to work with and manage groups with diverse backgrounds, abilities and ages.

Conflict management skills to analyze and resolve ambiguous or controversial situations and make difficult decisions.

Strong organizational and planning skills sufficient to oversee large projects, prioritize, and make recommendations or decisions on the direction of a project.

Knowledge of local, state and federal environmental laws, regulations and policies related to the conservation of natural resources.

Conflict management skills to analyze and resolve ambiguous or controversial situations and make difficult decisions.

### Physical Requirements

Requires occasionally lifting and/or carrying such articles as file boxes and heavier materials (e.g., boxes of printed materials, hunting and fishing equipment) with help from others and/or lifting and carrying light objects frequently. Even though the weights being lifted may only be a negligible amount, a job in this category may require walking or standing to a significant degree or may involve sitting most of the time.
