12. Summary Statement (200 words or less):

In a highly dispersed, non-centralized fisheries community the consequent lack of timely awareness of ongoing and planned research has resulted in inefficiency, duplications, and loss of opportunities, particular for state and provincial agency staffs. Past solutions depended upon regular participation by research and management staff in regional and national meetings, workshops and other forums are not effective in the current environment due to travel and staff restrictions. Yet effective web-based tools have not been developed to either supplement or replace past practices. The AFWA Science and Technology Committee has attempted to compile current research information through tedious and inefficient requests of documents that were then compiled into static reports, an exhausting and inefficient process. By efficiently building on the technical platform developed for the Grey Literature Clearinghouse (2019 MSCG funded project), this proposed Research Information Exchange Tool will provide an elegant and cost-effective solution for researchers and managers to be aware of current and planned research and create communities-of-interest around topics where collaboration will enhance and improve the research projects. The result will be a fisheries community operating with greatly enhanced knowledge of ongoing research working more effectively together to frame, implement and share the results of research programs.

Project Narrative

<u>Title</u> <u>Fisheries Research Tracking and Information Exchange Tool</u>

Problem Statement (350 words or less)

The fisheries management and research community is dispersed geographically and administratively through literally hundreds of agencies, universities, and other institutions nationwide. Frequently, this results in lack of awareness by management biologists, administrators and researchers, particularly state and provincial fisheries agency staffs, of existing research and research needs with consequent loss of coordination, inefficient duplication, and missed opportunities for collaboration. Past practice used professional meetings, working groups, or other in-person gatherings to share updates on current research and future needs. As the fisheries research and management community has diversified with new university, NGO and local partners, more frequent travel restrictions, and ever broader spatial needs identified, the challenge of even being aware of research activities, much less developing effective coordination, has been increasingly challenging. Given the limited resources for research and the substantial unmet need, the fisheries community needs to be as efficient as possible with research efforts.

Old-school efforts have been attempted to address this problem. For example, on specific topics individuals have contacted researchers and requested copies of research proposals which were then collated into a single document and distributed. This required an immense amount of work, resulted in a static and very awkward document that was outdated as soon as it was compiled. The development of better tools to provide for open access to ongoing and proposed fisheries research projects has been identified by WAFWA fisheries chiefs and others (e.g. AFS Fisheries Management and Administrators Sections) as a significant need. It is regularly recognized that fisheries staffs, particular at the state and provincial levels, are often unaware of ongoing research that would benefit substantially from coordination across states, regionally and nationally. Increased research activity awareness will greatly enhance efficiency of communication, data sharing and project improvements, and collaboration. Importantly, this information will be of critical importance in development of future research priorities and research agendas being addressed in a companion 2020 MSCG proposal under NCN16, *Assessing the State of Fisheries Research Agendas in the United States and Outlining Best Practices for Development of Agendas*.

Project Goals and Objectives (400 words or less)

1. Actively engage fisheries research and management community through an Advisory Committee

<u>Objective 1</u>. Work with WAFWA and other regional associations, AFWA Fisheries and Water Resources Policy and Science and Research Committees, and the AFS Fisheries

Administration and Fisheries Management Sections to develop a strong, diverse and representative advisory group to provide guidance, feedback and act as emissaries for this project. Many of the members of this advisory group are also currently involved in the MSCG 2019 project developing the Grey Literature Clearinghouse, thus are already engaged in working with the prime contractor on an issue with similar technical challenges.

<u>Objective 2</u>. Regularly engage the Advisory Committee in planning, design, progress review, and final acceptance of research web tool. Advisory group updates will be provided at annual meetings of AFWA and AFS committees and final demonstration of tool will be given by Advisory Committee members at a wide variety of events where appropriate.

2. Develop web interface and related tools for metadata and document storage, search and retrieval

Objective 1. Retain contractor for web tool development.

The prime technical contractor (ByRiver Tech LLC) has extensive experience in addressing the needs of this proposal and has already developed approaches building upon existing, tested applications. The Advisory Committee will be fully engaged in design, testing, and implementation of the tool.

<u>Objective 2</u>. Complete development of a complete and fully operational trial version of the research web tool in time for delivery to AFWA and AFS committees at fall 2020 annual meetings.

ByRivers Tech has already produced a development timetable that will meet deadlines and allow sufficient time for review and testing prior to fall meeting delivery dates.

3. Engage in outreach to research and management community through workshops using an appropriate online tool, science meetings, and conferences.

<u>Objective 1</u>. Distribute the research web tool to all state and provincial fisheries agencies. This can be done via direct contacts but also through sessions at appropriate AFWA and AFS committees.

<u>Objective 2</u>. Convene sessions or symposiums at conferences to build upon research information sharing and coordination.

<u>Objective 3</u>. Use other venues for distribution of research web tool such as Fisheries magazine article, working with National Association of University Fish and Wildlife Programs (NAUFWP), and other outlets and entities to inform potential partners of the tool and encourage use.

Program Methods and Design (600 or less)

We will develop a web-based tool and related information systems for state, provincial and other fisheries researchers to input critical metadata about current research projects on economically and recreationally important fish as well as other species of interest. The tool will provide the ability for researchers, fisheries managers and administrators to: search, find, and access critical project information; engage in information exchange; create new collaborations and efficiencies; and greatly enhance research awareness.

Key project features include:

- The project will be guided by an advisory team of fisheries managers, researchers and administrators from state, provincial, and federal agencies, universities and non-profits. This team will build upon the existing advisory panel for the Grey Literature Clearinghouse and will overlap extensively with the sister project proposed in the 2020 MSCG process to address development of research agendas and strategies. All advisory team members listed below have been contacted have agreed to participate. Additional members will be invited to address key gaps in coverage.
- 2. By efficiently building upon some of the software tools and approaches developed for the Grey Literature Clearinghouse project (2019 MSCG cycle), a web-based interface and related components (document storage, etc.) will be designed to allow efficient data entry of key metadata that effectively describe research projects. We have engaged ByRivers Tech LLC as the lead software developer for the project and their staff have already provided initial design proposals. ByRivers Tech is the lead contractor for the Grey Literature project and also does web development for AFS. Their knowledge of the fisheries community will be helpful in developing a product that meets needs of the target audience.
- 3. Build efficient and effective search tools to allow easy identification of research projects by topic (taxonomy, gear, etc.), geography (including a GIS mapping component), aquatic system type, researcher name, institution and other key criteria. Furthermore, the system will allow users to upload search criteria so that they are notified of new projects entered into the system that are of interest.
- 4. Upon completion of research projects, the interface will provide for linkages to research project results such as theses, dissertations, and publications. This will include linkages to documents stored in the Grey Literature Clearinghouse where appropriate.
- 5. Establishment of notifications so that users are informed of new research projects on topics of interest.
- 6. The tool will include fisheries community engagement capabilities that provide for dialogue between researchers and managers. This could include use of social media platforms, moderated chat boards or similar tools that encourage and support conversation among the users.

Deliverables and Benefits (450 or less)

This project addresses a number of clearly identified needs by the state, provincial and federal fisheries management and research community and will result in significant benefits:

- **A.** The web tool and research information system will greatly enhanced awareness of ongoing research throughout the country on a real-time basis. This will be immensely helpful in information sharing, reducing unnecessary duplication, and creating opportunities for efficiencies and collaboration.
- **B.** The web tool will substantially improve and enhance the work of a wide variety of working groups and committees that are focusing on defining research needs, developing coordination among disparate programs, or otherwise attempting to better identify and coordinate research activities in support of management needs.
- **C.** Enhance national efforts to document fisheries research in support of development national research needs and strategies statements.
- **D.** This project builds upon the structure and tools developed for the Grey Literature Clearinghouse (funded by MSCG in 2019) and will benefit substantially from efficiency and economy of the two related projects.
- **E.** This work will also support the companion project on "Assessing the state of fisheries research agendas" submitted in this MSCG round under NCN16 by building an information system on research activities.
- **F.** The project team will work with AFWA Science and Research Committee and Fisheries and Water Resources Policy Committee as well as relevant AFS Sections, Regional Associations of state agencies, the National Association of University Fish and Wildlife Programs, and federal agencies to engage all partners to the greatest degree possible.

Monitoring and Evaluation (250 or less)

The Advisory Committee has developed a timeline of project events and deliverables to ensuring project compliance with described goals and objectives. Key events, deliverable timetables and progress markers include:

- A. Initial design and project deliverable timetable.
- This will be established within 45 days of project initiation as set by federal funding approval and funding provision and will include the development and completion of subcontractor work order.
- B. Advisory Committee working calls will occur approximately every 30-45 days depending upon the development timetable.
- C. Delivery of test web site for research tool within 4 months of project initiation. Upon delivery, the Advisory Committee will review, develop any needed revisions to the schedule, and will approve final product development.
- D. Delivery of completed fully operational trial web tool for full distribution and testing by September 1, 2020.

- E. All additional changes and improvements will be completed by December 1, 2020.
- F. Tool will be fully available and implemented by January 1, 2021.

Experience (200 or less)

The four-person management team (Austen, Lerner, Mawdsley and Demario) and primary contractor (Grant Price) represent substantial experience in fisheries management and research at all levels in federal, state, NGO and private sectors and also incorporate a strong publishing, web development and information management expertise (Price and Lerner). This management team ties together related projects in such a manner that they will benefit from co-production. The Grey Literature Clearinghouse (Lerner, MSCG2019) utilizes a similar information infrastructure while a companion MSCG2020 project proposal (Research Agendas) makes the strong and crucial connection between knowledge of current research and developing effective research plans for future work. The project management team is intimately familiar with the regional associations, state and federal agencies and the various AFS and AFWA committees that will provide extensive access to the entire body of professionals who will need to be involved in this project. AFS brings considerable expertise and capacity in designing and managing information systems but also in supporting advisory groups such as has been developed to support this project. The project advisory panel brings to this project an immense amount of experience and knowledge of research management.

Qualifications of Key Personnel
