- Direct the work performed by the biodiversity division staff. Establish goals, priorities, and work ethics within the division. Oversee studies and projects for bird conservation; State wildlife grants; and threatened, endangered, and at-risk species.
- Performing public contact and liaison work with State and Federal agencies, nongovernmental agencies, and other environmental groups.

**Preferred Minimum Qualifications:** Graduation from an accredited college or university with a bachelor's degree in a natural resources management field and experience equivalent to five or more years of full-time work managing and/or supervising biodiversity and/or conservation staff. Experience coordinating research and managing funding is highly desirable. Previous experience working with executive and senior level management as well as internal and external stakeholders is preferred.
