


Why State Wildlife Agencies Participate

1. Compliments state investment of priority shared species
2. Leverages limited state funds (at least 1:1)
3. Annual Lifecycle Conservation makes sense
4. The program connects states to projects that help conserve shared priority species
5. Increases connections with partners across the Hemisphere
6. Birds are of great interest to citizens and are economically significant




30 Participating States




Mexico Grasslands Conservation

- IA, NE, OK, KS & SD
- Protect and restore native desert grasslands in Mexico's El Tokio Grassland Priority Conservation Area with ProNatura Noreste.
- Protected 49,381 acres of the Llano de Soledad grasslands and almost 116,000 acres through acquisition or conservation agreements in El Tokio.

A Region Wide Strategy in Caribbean Guatemala

- Forests within Guatemala's Caribbean Rainforest Corridor are a vital link in the Mesoamerican Biological Corridor and the Caribbean migratory flyway of Central America.
- Stop over and wintering habitat for at least 153 species of neo-tropical migrants.

Almost 9,000 acres of habitat
have been acquired for
migratory bird conservation in
Guatemala!



Cerulean Warbler Conservation

- Purchased 299 acres to expand the Pauxi Pauxi Reserve
- Planted 500,000 saplings on 2,828 acres
- Trained and educated over 4,000 to engage in conservation and raise awareness
