UPDATES

IUCN

Important outcomes of the World Conservation Congress were concerns about equity and inclusion, a recommendation to review the IUCN Sustainable Use Policy, and numerous resolutions (see back page). Recently, the Director had the opportunity to engage with the Chairs of the IUCN Commissions, the Director General, and the North American Regional Councillor.

CBD

The Open-ended Working Group is responsible for developing the Post-2020 Global Biodiversity Framework (GBF) for adoption at the CBD CoP in 2022. The GBF text negotiations are scheduled for March 2022.

CITES

The CITES Working Group on Zoonotic Diseases (WG) developed a list of opportunities and constraints to CITES engaging in and contributing to reducing the risk of zoonotic disease spillover in trade. The WG also developed a list of potential actions and is in the process of prioritizing them and making recommendations at the next WG meeting for consideration by the CITES Standing Committee.

WILDLIFE TRADE, USE, AND CONSUMPTION; ZOONOTIC DISEASES; AND ONE HEALTH

These discussions are front and center across the globe. There are proposals to ban wildlife trade, use and consumption in international fora and the U.S. Congress; develop new protocols under the UNCTOC; and action within CITES. One way to engage has been with the position paper developed by the Committee, Wildlife Conservation, Consumption, and Use in a Post-COVID-19 World.
