• Excited to be the new EOD chair; came thru the ranks of EOD so am personally invested

#### Reports from EOD Subcommittee and Working Groups

- Diversity & Inclusion- David Buggs (TX)
  - Had a very healthy group discussion
  - Revisiting our charge; will update by the AFWA Annual Meeting; soliciting volunteers for a steering committee to take on that charge
  - Coffee Talks- have been extremely successful; started a DEI in Practice series to go beyond the discussion aspect to people can start seeing DEI in action; next DEI Coffee Talk is on March 29 (Back Outside);
  - Think Sheet worksheet- looking at how the AFWA committees can be more inclusive
  - Looking at inclusive language in conservation; document put together by USGS
  - Discussed how to create student pipelines to get more diverse future employee pool
  - Stakeholder summit (aka DEI Academy)- centered around systems thinking that includes incorporating the work of DEI in our state agency
  - IHEA- initiative as to how be more inclusive in hunter education classes
  - Staying above the Fray- how you can systematically incorporate mor inclusion in the state agency system (possible topic for future coffee talk- suggestion)
  - Will reach out to people throughout the year about their Needs & Deeds
  - Discussion- some state agencies cannot use the phrase DEI, but have to use other verbiage (ex. People engagement); the end result is what's important even if you have to call it something else
- Education WG and Project WILD Subcommittee Tabbi Kinion (AR), Elena Takaki (AFWA)
  - We have the Conservation Education toolkit on the AFWA website; also have a Facebook networking group page
  - Working hard to create a network across the country of CE educators → Conservation Education Leadership Network bi-monthly calls; Next call May 4 at noon ET
  - Created top topics and training ideas → looking for speakers
  - Project WILD is focusing on thematic modules (instead of full activity guides); looking at electronic distribution and professional development/training
  - Have Earth Month webinar series in April (view info on AFWA website- schedule of

events)

- Wildlife Viewing & Nature Tourism Shelly Plante (TX)
  - Finished a Wildlife Viewing Survey (MSCG) and working on part 2 of that project now (a new MSCG)
  - Survey and webinar on the Wildlife Viewing Survey is available online
  - Creating a website on case studies of wildlife viewing with states that have incorporated the recommendations of the Wildlife Viewing Survey→ 19 states have participated in this new project
  - Pathways Conference May 31-June 2 in Colorado; a lot of wildlife viewing and nature tourism staff will be attending conference; full agenda is now online; registration still open
  - Wildlife Viewing and Nature Tourism Academy- Feb 2024 in North Carolina; call for proposals is now live; a practical academy for practitioners; goes beyond state agencies (federals, Canada, NGO, etc); 5<sup>th</sup> academy; fliers available to take home
  - Facebook- WVNT Working Group—please join (private group); lots of great information and assistance available
- Joint Working Group: Education, Outreach and Diversity and Wildlife Diversity and Conservation Funding Committees *Shelly Plante (TX)* 
  - Has focused on RAWA over the past few years; and will continue to focus on this, but also other areas
  - Discussed the path forward with RAWA and how this WG could help→ shovel ready projects, fact sheets, story maps, etc; looking for anecdotes of people oriented stories/quotes of the benefits of RAWA, economic stories and how RAWA would affect that and improve quality of life → work on template fact sheet to help gather this information and prioritize the states where we need to get the representatives on board and support RAWA
  - Look at gathering the best POC for state agencies and other groups to push out RAWA when it's 'go time'
  - Once RAWA does pass- this group will focus on telling the story of what the money has done, will do, and the timeline of this (results are not instantaneous)→ telling the story
- Outreach & Marketing Jenifer Wisniewski (TN), Tanna Fanshier (KS)
  - Looking at updated the Making It Last toolkit → rebranding as a communication relevancy toolkit; will include a section on effective communication about RAWA; will include a how to include relevancy in the hiring process; will have some pilot states with the proposed MSCG; will be looking to incorporate the One Health concepts in the updated toolkit
    - Florida- is looking at creating an outreach campaign to reach a broader and more diverse audience; will be one of the pilot states to test this new communication relevancy toolkit
  - Two successful R3 MSCG discussion: 1) Millenia/Gen Z phase 2 and 2) R3 through Pilot States- materials available on the R3 clearing house
    - Made video geared toward Millenia/Gen generation; posted in 4 states (VA, NE, TN, AZ) with great success and good feedback; ROI was over twice what was spent
    - R3 through Marketing- 50K grant to 15 states over the last 3 years to do R3 marketing; ROI average was over twice what was spent

# One Health – Ellen Haynes (SCWDS), Mark Ruder (SCWDS), David Stallknecht (SCWDS) Amanda Wuestefeld (IN)

- Hoping One Health will have impacts throughout the work we do
- One Health is a conceptual framework where people play a lot of diverse roles
- What is One Health?
  - Intersections of human, health, animal health, and environmental health
  - Origins in approach to zoonotic diseases
  - Used more broadly today
- Once health is a collaborative, multisectoral, and transdisciplinary approach- working at the local, regional, national and global levels- with the goal of achieving optimal health outcomes recognizing the interconnection between ,people, animals, plants, and their shared environment (CDC)
- Not a new concept; call different things over time
- Role of education & outreach: helping people understand we are part of, and dependent on, and ecosystem; we all positively and negatively influence our ecosystem
- There is a social detachment from our natural world
- People 'use' wildlife and natural spaces in different ways and natural resource agencies must engage in diverse communities
- Outreach and education (especially youth) are fundamentally important and impactful
- Public outreach and education needs to be included in the One Health discussion (under the umbrella); resiliency and thriving is a key message
- Might require another Think Sheet about how we will incorporate One Health in the AFWA Committee structure discussions
- Economics may need to be included in the One Health discussions

Discussion: Goals of the EOD Committee 2023

- What projects should we work on over the next year; possible multistate grant projects
  - Will be submitting another DEI grant and make the Academy more inclusive
    - Look at having a MSCG to sponsor people to attend the NA Conference that don't normally get to attend.—Corina with NWF is interested in working on this with AFWA; look at doing this for the regional association as well
- Restart the EOD Committee virtual meetings; create a standing call every 2-3 months
- How does the Association elevate the DEI Conversation?
- Progress measures discussion.
