Recently, the western states have identified this as a priority vector to address due to new populations of AIS being discovered as a result of stocking. The WISCE group is hoping that AFWA will support these new guidelines in hopes that other states and provinces will begin to incorporate these into their agencies.

2:45 Implementation of the national EDRR framework and coordination mechanisms with States and others

A coordinated national EDRR framework in the United States has been recognized as a critical need in multiple strategic planning documents in the last decade and in a Special Issue of Biological Invasions in 2020. These efforts have informed a blueprint to facilitate the communication, collaboration, and innovations necessary for an effective national Early Detection, Rapid Response (EDRR) program, especially for non-agricultural invasive species where such a framework is not comprehensively established on a national basis. Recent funding from the Bipartisan Infrastructure Law (BIL) has enabled DOI to advance numerous components of the Institutional Architecture of the Framework to enhance EDRR capabilities and coordinate at a national level to advance transformational outcomes that may not otherwise be achieved. DOI is committed to advancing the Framework in collaboration with other federal agencies, states, tribes, territories, other partners and invasive species management forums. DOI hopes to receive advice on how best to coordinate with AFWA and the States on implementation of the national EDRR framework.
