### **Updates**

#### **RAMSAR**

The Ramsar Convention on Wetlands 64th Standing Committee (SC) was held in January in preparation for CoP15 in July. We will review the SC decisions and the documents for CoP15 to determine if we need to develop positions or provide input to the U.S. State Department or other partners.

#### **CBD**

The Biodiversity CoP concluded the second resumed session of the CoP. One key decision was the opportunity for non-state actors to submit information about their work to conserve biodiversity and meet the Global Biodiversity Framework targets.

#### **Road to CITES CoP20**

Every three years, CITES convenes a Conference of the Parties (CoP). The AFWA CITES Technical Work Group has already begun preparing for CoP20 that will held from November 24 to December 5, 2025. Each of the regional associations of fish and wildlife agencies has a member on the Work Group. #### **IUCN**

The World Conservation Congress (WCC) will be held October 9 to 15, 2025. The online motions discussion forum will be an important place to influence the text of motions and then later in the summer vote on whether motions are approved. There are numerous motions that it maybe important to weigh in on. Some examples include the following. (continued next page)



- Increasing the participation of subnational governments across and through the Union
- Strengthening the Linkages Between Zoonotic Risks & Conservation Efforts
- Upholding indigenous peoples and local communities' rights to sustainable use in the face of harmful national and international legislation.
- Elevating the profile of the One Health approach within, across and beyond IUCN
- Maintaining, enhancing and restoring ecological integrity in conservation action
- Reaffirming IUCN commitment to sustainable use as a critical conservation tool
- Advancing the Sustainable Management, Use and Trade of Wild Species

Where possible, information should be provided in MS Word format, with a summary outlining the relevance of the practice to sustainable wildlife management.

The Work Group attended Standing Committee 78 in February. Toni Kerns (Atlantic States Marine Fisheries Commission), and Deirdre Gilbert (Maine Department of Marine Resources) also attended. The focus was to strengthen relationships with sustainable use partners, build connections with Country delegates, and engage in discussions on issues and potential species listing proposals leading up to CoP20. The Team also worked to try and advance a genus wide resolution on Anguilla spp. but it was not approved by the Standing Committee. Instead it will be taken up at CoP20 in fall 2025.
