CITES listing proposals and documents are being reviewed to develop AFWA positions. Stay tuned for an opportunity to weigh in on CITES topics.

Updates

RAMSAR

The Ramsar Convention on Wetlands CoP15 met in July. They approved the fifth Strategic Plan for 2025 to 2034. They also discussed topics such as waterbird population estimates, regional Ramsar initiatives, equitable governance, promoting sustainable lifestyles for the wise use of wetlands, the management of urban wetlands, the status of Ramsar sites, and more. Once the final documents are posted, AFWA will share any pertinent information.

CBD

Upcoming meetings include the 27th meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA) and the 17th CoP, which will be held in Yerevan, Armenia in the last quarter of 2026. AFWA will keep Directors informed about issues of importance.

Road to CITES CoP20

The CITES Technical Work Group—comprised of Stewart Liley (Western), Carolyn Caldwell (Midwest), Buddy Baker (Southeastern), Gordon Batcheller (Northeast), and Deb Hahn (AFWA)—has begun reviewing species listing proposals and related documents submitted for CoP20. positions. They are working closely with partners to advance member priorities and gather scientific and policy information. Among the listing proposals submitted are several involving species native to the U.S. and Canada, including:

- All *Anguilla* species: inclusion in Appendix II, with a delayed entry into effect until June 5, 2027
- Several manta and devil ray species: transfer from Appendix II to Appendix I
- Oceanic whitetip shark: transfer from Appendix II to Appendix I
- All gulper shark species: inclusion in Appendix II
- Select sea cucumber species: inclusion in Appendix II
- Genus-wide listings for *Crotalus* and *Sistrurus*: inclusion in Appendix II
- American ginseng: exempt products from artificially cultivated ginseng
- Peregrine falcon: transfer from Appendix I to Appendix II (submitted by the U.S. and Canada)
