Position Summary: The Association of Fish and Wildlife Agencies (AFWA) is seeking a

Wildlife and Energy Program Coordinator to lead AFWAs efforts on energy and wildlife issues. The coordinator will staff AFWA's Energy & Wildlife Committee and related working groups; serve as a key liaison among state fish and wildlife agencies, federal partners, the energy industry, and conservation organizations; and advance collaborative solutions to avoid, minimize, and mitigate conflicts between energy

development and wildlife conservation.

Key Responsibilities: Committee & Working Group Support: Provide staff support for the

AFWA Energy and Wildlife Committee, Wind & Wildlife Working Group, and Solar and Wildlife Working Group. Oversee communications, coordinate meetings and forums, manage work products, and lead

implementation of annual work plans.

Partnership & Network Building: Maintain and expand a national network of leaders and practitioners from state, federal, NGO, and

industry partners engaged in energy and wildlife issues.

Policy & Technical Expertise: Develop, review, and provide input on energy and wildlife policies, research priorities, best practices, and emerging technologies. Represent state fish and wildlife agency interests in regional and national discussions related to wildlife and

energy siting, development, and transmission.

State Wildlife Action Plans: Support the revision and application of State Wildlife Action Plans to address potential energy-related impacts

to Species of Greatest Conservation Need.

External Representation: Participate in national partnerships such as the Renewable Energy Wildlife Institute, Avian Solar Working Group, Bat and Wind Energy Collaborative, and others as needed.
